## **What This Notice Covers**

This Notice applies to your use of Website and Services operated by us. Please be aware that for certain other services rendered by other Rakuten Group companies, we or the other Rakuten Group companies may provide you with separate privacy notices applicable to those services.

## The Information We Collect

For the purposes stated in the Section titled "Use, Legal Basis of Use and Retention of Your Information", we collect information about you as described in this Section. This includes information that you give us

directly, information about your use of the Services, and information received from third parties. All the personal information that we collect and use in accordance with this Notice is centrally managed and stored by Rakuten India.

We may obtain information about you from other sources such as our third-party marketing and outreach partners. We may combine this information with those listed above, or collected through your use of the Website or Services.

# Use, Legal Basis of Use and Retention of Your Information

We use your personal information to provide you information regarding our Services, including demos, product details, security information, and other particulars regarding Services and their functionalities, and access to our Website.

We will also user your personal information to advertise and market our Services in accordance with your interests and preferences, to conduct research and development, to respond to customer inquiries, and to prevent and mitigate fraudulent or illegal activities.

### **Use of Your Information**

Specifically, we may use your information for the purposes listed below:

To provide you with details regarding our Website and Services:

- For the provision of personalized services, content, and information related to the Services.
- For the provision of product information such as pricing, demos, security information, and other such particulars.

*To provide you with advertisements, promotion and marketing content:*

To undertake service improvement, research and development:

To respond appropriately to customer inquiries:

• So that we may respond appropriately to customer inquiries, complaints, or requests in relation to our Services, advertisements, and marketing.

To prevent and mitigate fraudulent or illegal activities:

• For the prevention, identification and investigation of scams, cyber-attacks, and other potentially illegal or fraudulent activities, or in relation to any other activities necessary to protect the legal rights of Rakuten India, the Rakuten Group and/or the rights of third parties.

# **Legal Basis of the Use of Your Information**

In the European Economic Area, we are obliged to have a legitimate reason (or legal basis) for each processing activity and in most cases, the basis on which we rely will be one of the following:

- to fulfil our contractual obligations to you, for example to provide Services to you in the event that you purchase them;
- to comply with our legal obligations, for example to provide you with necessary information to ensure the Services you purchase are in accordance with committed service levels; and
- to meet our legitimate interests, for example to understand how you use the Services and to improve them and to provide tailored marketing messages to you via certain channels.

#### **Retention of Your Information**

Unless instructed by you, we will keep your personal information necessary to fulfil our contractual obligations for as long as we have a relationship with you, and for a period of three (3) years thereafter. We will only retain your personal information after this time if we are required to do so to comply with the applicable laws, or if there are outstanding claims or complaints that will reasonably require your personal information to be retained.

### Disclosure of Information about You

Disclosure to our vendors

We provide your personal information to sellers and relevant service providers (each a "Merchant"), including those located outside of India, when you use the Website or Services. These include:

- customer relationship management services and forms integrated with our Website;
- hosting of our products on cloud services;
- service providers engaged to communicate alerts.

### Disclosure to Other Third Parties

In addition to the disclosures described above, we may also disclose your personal information to certain trusted third party service providers, including those located outside of India, where necessary to carry out our business operations.

Please be assured that we will only disclose your personal information in compliance with the applicable law, and with the appropriate management and supervision of the relevant third parties.

On occasion, judicial or regulatory authorities may request access to or disclosure of information about you for law enforcement purposes. Such requests typically pertain to criminal investigations or other legal proceedings. Where they are necessary and legitimate, we will respond to such requests in accordance with our internal policies and applicable law.

Additionally, in cases where it is necessary to prevent and mitigate fraudulent or illegal activities, or to protect life, body, or property, we may disclose your personal information to another Rakuten Group company or to a third party.

Furthermore, we may share your personal information with any third party that purchases, or to which we transfer, all or substantially all of our assets and business. Should such a transfer occur, we will use reasonable efforts to try to ensure that the entity to which we transfer your personal information uses it in a manner that is consistent with this Notice.

We may disclose any types your information in the section titled "The Information We Collect" to the minimum necessity in order to achieve the purpose of the disclosure.

We will not use or disclose your information for purposes not set forth in this Notice without informing you and taking any necessary steps in advance as required under applicable law.

# Your Rights and Choices

Your Rights

Once we receive the request, we will verify your identity based on your personal information that we already have and that we may additionally require from you for the verification purpose.

In the event your user account and personal information is provided to us by your employer, we will initiate your request/ inquiries with your employer for the purposes of verification. Once verified and instructed by your employer to address or carry out your request/ inquiry, we shall do so within the timeline provided under applicable law.

Please note that we may also require additional information from you in order to respond your request appropriately.
